

**AGREEMENT WAIVING LIABILITY FROM
MEDITATION AND RELATED EXERCISES AND PRACTICES**

1. The agreement is entered between the undersigned student and SKY Manavalakalai Mandram Meditation centre, CA, a Non-profit organization, hereinafter SKY Bay Area, CA, signing this agreement for SKY Bay Area, CA, is a certified SKY Master of SKY Bay Area, Fremont, California here after referred to as the SKY Master and who hereby warrants that he/she has full authority to bind and SKY Meditation centre, CA to the terms of this agreement.
2. In consideration of the opportunity to study meditation and related exercises and practices under the direction of and or in the presence of the SKY Master, student shall agree to and abide by all the terms and conditions contained in this agreement.
3. Student recognizes that neither the SKY Master nor the SKY Bay Area, CA, makes any claims to having the capacity to diagnose any physical, mental or emotional ailment or disability. Student thus hereby relieves the SKY Master and the SKY Bay Area, CA of any liability for any failure to so diagnose.
4. Student further recognizes that neither / nor the SKY Bay Area, CA, is responsible for referrals to any health care practitioner for physical, mental or emotional condition and hereby relieves the SKY Master and SKY Bay Area, CA, of any liability for the onset of physical, mental or emotional conditional that may or may not arise pursuant to practice of meditation and related endeavors.
5. Student acknowledges that the practices of meditation and related endeavors **may be** un welcome as well as sought after physical, mental and emotional conditions, student thus hereby relieves the SKY Master and SKY Bay Area, CA, of any liability for the onset of physical, mental or emotional conditional that may or may not arise pursuant to practice of meditation and related endeavors.
6. Student fully understands and acknowledges that the SKY Master and SKY Bay Area, CA are not legally bound by any claims that either of the aforementioned may make about any ability to actually enhance the welfare in any way of any person, including the student. Student further accepts that each individual may respond differently to the type of practices, to which he or she may be exposed by the SKY Master and / or SKY Bay Area, CA, and that the degree of satisfaction with one's student with the SKY Master and / or SKY Bay Area, CA, may vary drastically from one person to the other, based on a multiplicity of factors. Student hereby relieve the SKY Master and / or SKY Bay Area, CA, of any liability for any absence of progress, in any area of life that student might experience, in the course of studying the practices or using the published materials offered by Shri Vethathiri Maharishi and/or SKY Bay Area, CA.
7. Student assumes full responsibility of his/her own physical, mental and emotional safety, at all times which student may incur at any time and all times from any causative element in the environment in which student might find himself or herself. Thus, student hereby relieves the SKY Master and /or SKY Bay Area, CA, of any and all liability for any physical, mental or psychological injuries that student may ever incur because of or during or as a result of

participation in any of the practices or techniques taught by the SKY Master and / or SKY Bay Area, CA.

8. Neither the SKY Master and / or SKY Bay Area, CA, insure in anyway, nor guarantee, the efficacy of the opinion in question. Thus, student hereby relieves the SKY Master and / or SKY Bay Area, CA, of any liability for the consequences of student's acting upon or failing to act upon any advice given by the SKY Master and /or SKY Bay Area, CA or any person representing SKY Bay Area, CA, with respect to any facet of student's life.

It is the intent of student and the agreement of the parties to this agreement that all the releases and relief from liability the student gives the SKY Master and /or SKY Bay Area, CA, also extends to any person acting on behalf of the SKY Master and /or SKY Bay Area, CA, and all the heirs assigns, legatees, inheritors in any form, spouses, community property corporations, or any other person who might stand in legal relationship to the person so being relieved of liability, partnerships, sole proprietorships and any conceivable legal entity of the person who is hereby being relieved of liability.
